## 4. Terms and Conditions

We, the undersigned, agree to abide by the rules and regulations outlined in the exhibitor's manual, and the move in and move out schedules.

Liability: Exhibitors indemnify and hold harmless the Oklahoma Petroleum Marketers and Convenience Store Association, the Oklahoma Grocers Association and the Oklahoma Wholesale Marketers Association for all liability (damage or accident) which might ensue from any cause resulting from or connected with the transportation, placing, removal or display of exhibitors. Exhibitors are urged to insure themselves against such risk or loss of liability. Although guards will be on duty, the above mentioned associations do not guarantee exhibitors against loss by theft or otherwise.

The Oklahoma Super Trade Show Board of Directors reserves the right to decline or prohibit any exhibit which in its opinion is not suitable or not in keeping the character of the exhibition. The deposit is 25% of the total cost of the booth space and is due with the refundable \$100 dismantling deposit and the submission of this contract. It is non-refundable after January 15, 2021. The balance is due on or before **April 1, 2021** and non-refundable after that date. Booths reserved after April 1, 2021 will require payment in full at the time the booth is reserved. Booth assignments are not guaranteed until the balance is received. Multi-booth reservations receive a 5% discount.

Dismantling Deposit: A dismantling deposit of \$100 per company will be required. This deposit will be returned to the contracting company if the booth is not dismantled before the show officially closes on Wednesday, May 5, 2021 at 3:00 pm. Booths may be dismantled from the time the show closes until 10:00 pm. **These times are subject to change. Dismantling of booth before the show officially closes will result in forfeiture of the \$100 dismantling deposit.**

By signing and dating this Exhibit Booth Contract, exhibitor agrees to all terms and conditions as stated herein for participating in the Oklahoma Super Trade Show including receiving communications by or on behalf of the Oklahoma Super Trade Show and hereby authorizes third party communications via postal mail, fax, email and/or telephone.
